Courses Taught

- Career and Lifestyle Development (Online Asynchronous) A reflection of the changes
 of the role of work and career to individuals and society as a whole. Students explored
 work ethics and values as they changed in response to the rapidly shifting economy.
 Additionally, this course focused on multicultural aspects required by vocational
 counselors to understand the different ethics and values that various cultures have, and
 the major diversity issues that many cultures encounter.
- Foundations of Psychotherapy (Online Synchronous; Face-to-Face) An introduction to the counseling and consultation process with an emphasis on knowledge acquisition and skill development in common counseling processes and their application. A special emphasis on the use of empirically supported theories, psychotherapeutic techniques, as well as the relational processes that empower clients to meet their goals collaboratively, within the counseling context.
- *Practicum/Internship (Online Synchronous; Face-to-Face)* The practicum/internship seminar is a series of three courses (Practicum Seminar I, Internship Seminar I, Internship Seminar II) that focus on helping counseling students develop the full range of counseling skills to promote resilience and well-being in diverse populations.
- Professional, Legal, & Ethical Issues in Counseling (Online-Synchronous; Face-to-Face) Students learned: 1) An overview of the development and current status of the helping professions, with a specific focus on mental health counseling as practiced at the Master's level and, 2) A foundation in the major legal, ethical and professional issues impacting the practice of counseling in Pennsylvania. Students were trained to gain a command of the American Counseling Association (ACA) Ethics Code, National Board of Certified Counselors (NBCC) Ethics Code, and relevant PA State Code and case law.
- *Trauma Counseling (Online-Synchronous; Asychronous)* This course explored how trauma impacts not only one's cognitive and emotional processing, but also dysregulates one's neurophysiology, and discussed evidence---based assessments and interventions that counselors can use to help alleviate the negative impact of trauma with their clients.
