Numerous lay and professional trainings offered each year on topics such as anxiety, OCD, complex PTSD, depression, sex therapy, addiction, premarital topics, professional ethics, marital enrichment, counselor self-care, clergy care, clergy sexual abuse, and sexual/gender identity.
