### **COURSE DESCRIPTION**

Trauma has been described as "the mission field of the 21<sup>st</sup> century" by Diane Langberg, a clinician with decades of experience working with trauma survivors. This course will provide an overview of trauma and its impact as well as guidance for how counselors and ministry leaders can provide care for trauma survivors. The course will facilitate exploration of this topic from both a theological and counseling lens.

I graduated from Missio's MA in Counseling program in 2010. Since then I have had the privilege of walking alongside of courageous trauma survivors on their journeys of healing. ### **SYLLABUS**

### PROGRAM GOALS AND COURSE OBJECTIVES

The goal for this course is to provide an introduction for counselors and ministry leaders of trauma; its impact; how to provide ethical, competent, and compassionate care to trauma survivors; and articulate characteristics of a trauma-informed church.

At the conclusion of the course, students should be able to:

- 1. Define trauma and articulate a theological understanding of trauma and healing;
- 2. Demonstrate an understanding of the impact of trauma in the lives of victims;
- 3. Demonstrate the ability to conceptualize psychological, pastoral, and ethical care for trauma survivors; and
- 4. Identify characteristics of a trauma-informed church.

### ASSIGNMENT DESCRIPTIONS AND GRADING

## **Application Paper (3-4 pages).**

This assignment is an opportunity to reflect on the reading and course content and apply it to your ministry context. You can develop a plan from the reading and course content for making your church or ministry more trauma-informed. Or, you can reflect on how to provide safe, compassionate pastoral counseling or care to trauma survivors in your church or ministry context. Your paper should demonstrate that you understand trauma and key components of the healing journey through both counseling and theological lenses, the way it impacts your chosen population, your role (or dual roles), and any identified barriers to providing safe, compassionate care and community.

### **COURSE SCHEDULE**

The morning will focus on understanding Trauma- and Stressor-Related Disorders through counseling and theological lenses, the impact of trauma on specific populations (i.e. sexual abuse survivors, veterans), and key components of the treatment/healing journey. The afternoon will cover trauma-informed churches and ministries with practical suggestions for ministry leaders desiring to make their churches safer for survivors.

### **GRADING SYSTEM**
